DATA SUBJECT APPLICATION FORM

At Pulver Kimya Sanayi ve Ticaret A.Ş. (“**Pulver**”), protecting the privacy of private life, especially protecting fundamental rights and freedoms, ensuring and protecting the security of information, and respecting ethical values are among our priorities. Article 11 of the Personal Data Protection Law (“**PDPL**”) No. 6698, titled "Rights of The Data Subject" grants data subjects to make certain requests regarding the processing of their personal data. As Data Controller, our Company drafted this application form in order to enable Data Subjects to exercise their rights and to fulfill its obligation to inform within the scope of Article 10 of the PDPL.

As per Article 11 of the PDPL, you can exercise the following rights by filling in the attached form and submitting it to Pulver:

- a) Learning whether your personal data are processed or not,
- b) If your personal data have been processed, you can request information regarding this,
- c) Asking about the purpose of processing your personal data and whether they are used in accordance with the intended purpose,
- d) Inquiring about the third parties to whom your personal data are transferred, at home or abroad,
- e) Requesting the rectification of the incomplete or inaccurate data if any,
- f) Requesting the erasure or destruction of your personal data under the conditions referred to in Article 7,
- g) Requesting the reporting of the operations carried out pursuant to sub-paragraphs (e) and (f) to third parties to whom your personal data have been transferred,
- h) Objecting to the occurrence of a result against you by analyzing the data processed solely through automated systems,
- i) Claiming compensation for the damage you have suffered due to unlawful processing of your personal data.

As per Article 13 of the PDPL, data subjects shall submit their requests to our Company in writing or by other methods designated by the Personal Data Protection Board (“**Board**”). In this context, applications can be submitted to our Company free of charge after this form is filled in and printed out, choosing one of the four methods below.

Third persons shall not exercise the right to receive information granted within the scope of Article 11 of the PDPL on behalf of data subjects. In order for the data subject to make a request about the personal data relating to a person other than themselves, the original copy of a notary-approved special power of attorney with a wet signature, issued by the data subject on behalf of the applicant, shall be submitted.

In the event that the request submitted by the Data Subject requires an additional cost, our Company shall collect the fee specified in the tariff by the Personal Data Protection Board.

Your application shall be answered within thirty days from the date your request reaches our Company, depending on the nature of the request, in accordance with Article 13(2) of the PDP Law. Our response shall be delivered to you in writing or electronically as per Article 13 of the PDPL.
